Open Access Platform

#### Managing APC requests made easy!

Welcome to Elsevier Open Access Platform. Here's how it works:

When there are new requests you'll receive a notification in your mailbox. On the platform you'll be provided with all relevant data (such as DOI-link, author credentials, journal and more) to effectively validate requests. You can then accept or reject the request. You can also notify the author on decisions made.



- Society Membership Number






